## **Sector Challenges in the Western Balkans**



- Heavy reliance on fossil fuels and high end-user consumption
- High investment needs to modernise network infrastructure, increase digitalisation and prepare systems for the use of renewable and waste heatbased solutions
- Competition from alternative forms of heating, often low cost and highly polluting

## **Pristina Solar District Heating Project Kosovo**



EBRD Finance GHG Reduced € 23.2 million 49,000 tonnes of CO<sub>2</sub> eq / yr

Supporting the City of Pristina in the construction of a **solar thermal plant** to provide additional heat energy capacity and extension of the district heating network

- An innovative solution to increase the use of renewable energy for heat supply
- GCAP follow-on investment, addressing priority environmental challenges in Pristina
- First time deployment of this technology in Western Balkans
- Connect ~35,000 people to Pristina's district heating network




## **Public ESCO Project Serbia**



EBRD Finance GHG Reduced € 50 million 20,000 tonnes of CO<sub>2</sub> eq / yr

An innovative approach to financing energy efficiency improvements in multi-storey residential buildings across cities in Serbia delivered by municipal utility companies.

- Repayment over lifespan of loan via heating bills
- Significant improvement in thermal comfort and increased lifespan of existing building
- Will facilitate a transfer from flat-rate heat pricing to consumption-based billing for households
- Grant support from SECO and EU



## ReDE Serbia Programme Serbia





## **Project**

- Programme of renewable and waste heatbased investments in 10 Serbian cities
- Heat sources include: air, data centre heat, drinking water supply, geothermal, river water and treated wastewater
- ~30 MW of heat pump capacity, 115 GWh
   p.a. of heat based on RE and waste heat



## **Financing Structure**

- Sovereign loan to Republic of Serbia with a central project implementation unit in the Ministry of Mining and Energy
- Overall capex ~ EUR 37.5 M
  - EBRD loan: EUR 30 M
- Donor support from Switzerland and EU: EUR 7.5 M

## Challenges


- Great **biodiversity values** species (including endemism) and pristine habitats
- Provide valuable benefits and many ecosystem services
- Diversity of landscapes with high potential to deliver ecosystem services
- Protected areas have been designated for many years; valuable transboundary areas exist (such as Shara-Korab-Koritnik, Prespa region etc.)
- Steps towards identification of future Natura 2000 sites and identification of ecological corridors
- Initiated activities for **restoration** (forest landscape plan, riparian habitats, reforestation, etc)
- Regular and standardized biodiversity monitoring for small number of species; collected data for endemic species in WB
- Some steps for integration of climate
- ...


- Inadequate protection of biodiversity, leading to the loss of threatened species and habitats
- Protected areas: the network is falls short of global and EU Biodiversity targets, which call for 30% of land to be protected and 10% under strict protection
- Management effectiveness of PAs is lacking
- Connectivity of PAs is weak and eco corridors are not recognized
- Legislative Gaps: Transposition of EU Bird and Habitat directives is incomplete
- Development Pressure: impact to biodiversity from urban and infrastructure development
- Sectoral Policy: Biodiversity considerations are often overlooked in broader sectoral policy development
- Illegal practices are occurring affecting biodiversity
- Institutional arrangement are inadequate and often under-resourced. Political changes jeopardize the implementation of biodiversity goals
- Cooperation and knowledge exchange is inadequate
- Data collection: non-standardized leading to inconsistency
- Awareness and knowledge: law awareness and understanding of biodiversity benefits and their integration into climate and other plans
- Funding Shortages dedicated to biodiversity conservation

## The way forward

- Conduct comprehensive baseline studies and assessments of biodiversity (including standardized data collection)
- Expand the **network of protected areas** and **enhance the management** effectiveness of existing sites
- Consider of Emerald network areas during the identification and prior to designation of Natura 2000 sites
- Implement green infrastructure and improve habitat connectivity through spatial planning and sectoral plans
- Strengthen transboundary cooperation and coordinated management of the transboundary clusters of protected areas and corridors
- **Ecosystem services and PES schemes** are helpful/effective tool for biodiversity conservation and climate change mitigation; these should be integrated into sectoral polices and management plans
- **Legislative compliance**: finalize the transposition of EU Bird and Habitat directives into relevant legislation and enhance enforcement efforts to mainstream biodiversity
- Alignment of NBSAPs with post 2020 global and EU biodiversity targets, while considering other Rio conventions.



## The way forward


- Implement landscape level planning and conservation to minimize pressures on biodiversity caused by rapid development.
- Ensure **compliance with environmental standards and permit** procedures related to the impact of infrastructure projects on biodiversity. This include EIA and SEA along with robust monitoring of the implementation of proposed measures.
- Enhance **restoration efforts** by adopting holistic, systemic and long-term approach to ecosystem recovery
- Improve oversight and **control of illegal practices** at site level, including raising awareness and knowledge to the judiciary system regarding the importance of environmental protection
- Facilitate knowledge exchange on enhancing biodiversity, utilizing best practice examples such as Nature Conservation program
- **Empower youth** as a crucial target group in nature conservation efforts fostering their involvement and leadership in biodiversity initiatives
- Allocate sufficient and sustained financial resources for biodiversity conservation. This
  may include various mechanisms such as agri-environmental schemes, environmental taxes,
  and other funding sources.








#### **Status of Implementation:**

- The use of Nature-Based Solutions is being explored to increase ecosystem and community resilience.





### The Swiss 'P5 Portfolio' in the WB


#### **NORTH MACEDONIA**

**Cumulative Swiss contribution 2012-2024** 





**Cumulative Swiss contribution 2012-2024** 



#### Focus of the Swiss P5 Portfolio

- 1) Nature Conservation Programme in North Macedonia (2012-2024), SDC 11 Mio CHF, Farmahem- Helvetas
- 2) Green Agenda, in Serbia (2022 2026), SDC 4.5 Mio CHF UNDP (EU, Swiss, Sweden)
  - > Framework legislation; piloting innovations along the 4 pillars; scaling up successful pilots
  - most important impact is mobilization of all relevant ministries and partners for implementation of the GA and mobilization of the private sector via challenge calls.
  - → BD is 1 of 4 pillars supported by SDC:
  - 1<sup>st</sup> batch support 9 pilot projects (total value of 0.7 mio E, of which 0.4 from SDC)
- **3) PRO Local Governance for People and Nature,** in **Serbia,** (2023-2026), SDC 9.6 mio E UNOPS, UNICEF, UNFPA, UNEP
- > Strengthening capacities for participatory development of local environmental and climate related policies
- → Implementing local environmental protection projects
- > Youth empowerment and participation in green agenda





- Support to institutions at all levels to implement priorities of the National Strategy for Nature Conservation - introducing ecosystem services and regional forest planning and development, as well as new concepts for integrated management of natural resources.

- identification of 3 Natura 2000 sites and preparation of the relevant documents in line with EU directives.

#### **ISSUE SHEET 2**



#### BIODIVERSITY ASSESSMENT AS A BASE FOR DECISION-MAKING

Planning and managing the conservation of biodiversity requires a sound knowledge of all the existing animal, plant and fungal species within a given area – their status, their habitats, and the possible threats that they face. Accordingly, the Nature Conservation Programme (NCP) placed emphasis on the rigorous scientific collection of data in the field, and the analysis of this data to create a sound documentation base. This Issue Sheet describes the biodiversity assessment process and should be read in conjunction with other Issue Sheets, especially numbers 1 and 3. They partner in all this work was the Macedonian Ecological Society (MES), a national NGO with a highly experienced team of specialist scientific staff.

"The NCP succeeded in designing interactive and efficient management of biological databases, establishing a common methodology in biodiversity research and setting new standards which were followed in most of the subsequent conservation projects throughout the country. The usefulness of the ESM was proven when it was taken as base for elaborating a national level version for the Authoral Spatial Plan (2021-204/1) Prof. Dr. Slavco (Institutosis)




